- Facility: Austin Table Tennis Club, 8227 North Lamar (Bldg 3 - 2 story building in back), Austin, Texas. Play will be on wood floor with good lighting and air conditioning.
- Equipment: 8 new European Stiga tables, Yasaka Master nets, orange 3 Star 40 mm balls.
- Eligibility: Open to all members of USATT. If you're not already a USATT member, join when you enter the tournament (send your membership fee along with your entry fee) and get the magazine and stuff for \$40. Juniors (under 18) may join for \$20.
- Format: Singles: Three phase round robin with A through F divisions. Preliminary round robin groups will be played to determine singles divisions. The top finisher in each round robin group will advance to the A group, second place finisher will advance to the B group, etc (all players play phases one and two). Second phase will feature two round robin groups in each division. In the final phase the top four players in each division (two from each group) will play cross-over matches with matches from phase two carried over. Final matches should be over by 7pm.
- Doubles: Two divisions: U3200 and Open (latest ratings from USATT) to be played between the first two phases of singles. Single elimination unless the number of entries is rather small. Feel free to sit this out. No money is involved.
- Reporting: Players must register at the desk at least 15 minutes before 9:00am.
- Practice: The Austin Table Tennis Club will be open for practice from 6-10 Friday and at 8am on Saturday.
